## **PRESS RELEASE**

### ***Breaking and Entering Suspects Arrested***

---

On November 16<sup>th</sup> North Kingstown Police arrested Ronald Grasso (42 years old) of 6101 Post Rd Lot 79, North Kingstown and Alyssa Colaluca (23 years old) of 26 Nelson St, Providence for a Breaking and Entering that just occurred in the Town of West Warwick. North Kingstown Police were alerted by West Warwick Police that a dark SUV bearing RI registration 678-814 was believed to be involved in the Breaking and Entering that just occurred in West Warwick and that the vehicle may be enroute to 6101 Post Rd. North Kingstown Police responded to 6101 Post Rd where the vehicle was located, however, it was unoccupied. Grasso, who matched the description of the person seen in the West Warwick Breaking and Entering, was located a short distance from the vehicle where he was questioned and taken into custody. Police subsequently located the items stolen from the West Warwick Breaking and Entering as well as items for a Breaking and Entering that was committed in the Town of East Greenwich. Alyssa Colaluca was arrested on a Superior Court Bench Warrant and later charged by West Warwick Police for Conspiracy to Commit Breaking Entering.

North Kingstown & East Greenwich Detectives subsequently executed a search warrant on 6101 Post Rd Lot 79 where property related to Grasso's Breaking and Entering offenses were located. Items seized were tools used by Grasso to break into houses, thirty grams of marijuana and evidence related to a Breaking and Entering in the Town of South Kingstown.

In a joint investigation involving Detectives from North Kingstown, West Warwick, East Greenwich, and South Kingstown Police, Grasso and Colaluca are expected to be charged with Breaking and Entering by the above police departments as well.

North Kingstown Police Charges:

- Two counts of Breaking and Entering
- Two counts of Receiving Stolen Goods (over \$500)
- One count of Felony Possession of Marijuana
- One count of Possession of Burglary Tools

Grasso and Colaluca were arraigned in Third District Court on November 17<sup>th</sup> and are currently being held at the Adult Correctional Institute.

This matter remains under investigation as more charges may be forthcoming.
